

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.nauticaescape.com and Nautical Escape and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Nautical Escape include www.nauticaescape.com, NE and Our Best Lyfe. The NE website is a Travel and Vacation site. By using the NE website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, NE may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase NE's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
